City Commission Regular Meeting Tuesday, August 27, 2025

Mayor Fred Cleveland called the meeting to order. Also in attendance were Vice Mayor Valli Perrine, Commissioners Randy Hartman, Lisa Martin and Jason McGuirk.

ANNOUNCEMENTS/PRESENTATION/RECOGNITIONS

Senator Tom Wright presented a \$837,500 check to the City for the North Atlantic Stormwater Project.

Sharewear founders Amanda Anderson and Lyndsey Allender were recognized for their donation of digital safety bracelets to the NSB Police Department.

CITY MANAGER'S REPORT

- City Manager, some staff and Commissioners attended the Florida League of Cities Conference
- City Manager and Commissioner McGuirk attended the Chamber of Commerce Day for Leadership in the City of Edgewater.
- Advised that 120 Flagler Ave. RFP's will be opened on Sept. 23
- Advised that clarification is needed concerning the State's grant reimbursement for the Women's Club so that may be added to the sales contract.
- City Manager will meet with Parking Study consultants to review findings. Consultants will meet with each Commissioner to discuss findings. A public meeting will be held on Sept. 24.
- Last week's public participation included over 20 people in opposition to the Parking Garage on 3rd Avenue.
- City Manager is looking into feasibility as part of the Turnbull initiative of buying land on Paige Ave. to be turned into a conservation area.

ORDINANCES - SECOND READING AND PUBLIC HEARINGS

9.A Ordinance No. 43-24: Conduct the Second Reading and Public Hearing of an Ordinance to approve a Zoning Text Amendment to the City Land Development Regulation that would remove the use of church and replace with house of worship and add a new definition and make the use permitted in certain zoning districts. The amendment would also replace the use of drug store with pharmacy and add a new definition.

Motion to approve passed unanimously.

9.B Ordinance No. 44-24: Conduct the Second Reading and Quasi-Judicial Public Hearing of an Ordinance to amend the text of the B-3 zoning district to add Pain Management Clinics to the B-3 Highway Service Business District as a Special Exception

Motion to approve failed (2-3) (Martin, Cleveland and Perrine voted no).

9.C Ordinance No. 49-24: Conduct the Second Reading and Public Hearing of an Ordinance to revise charges for household and commercial solid waste.

Motion to approve passed unanimously.

9.D Ordinance No. 50-24: Conduct the Second Reading and Quasi-Judicial Public Hearing of an Ordinance that would rezone approximately 0.34 acres of land to B-4, Ocean Commercial on a vacant property located at the southwest corner of 7th Avenue and South Atlantic Avenue.

Motion to approve passed 4-1. (McGuirk voted no).

ORDINANCES – FIRST READING (Second Readings & Public Hearings on September 10, 2024)

10.A Ordinance 51-24: Conduct the First Reading of an Ordinance, which if adopted upon the Second Reading and Public Hearing, would rezone approximately 1,618 acres of land located south of State Road 44 and west of I-95, known as the Deering Park Innovation Center (DPIC), to Planned Unit Development (PUD) from the current zoning classifications of A-1 Prime Agriculture, Forestry Resource (FR), and Conservation (C).

A motion was made and seconded to continue the first reading to October 22, 2024. **Motion carried unanimously.**

MAYOR AND COMMISSION REPORTS

Vice Mayor Perrine commented about City Manager Resheidat. She shared that she would miss him. She reminded the public about the Thursday evening farewell party for City Manager Resheidat.

Commissioner Hartman thanked staff for their hard work regarding Venetian Bay parking issues. He commented on the stormwater issues. He commented on revisiting the moratorium in January and looked forward to the new data.

Commissioner McGuirk commented on the auditing committee and appreciated the work they put into it.

Mayor Cleveland commented on parking enforcement and thanked the elected officials offering their opinions prior to a quasi-judicial hearing

CITY ATTORNEY'S REPORT

A motion was made and seconded to authorize the City Attorney's Office to proceed with filing an eviction regarding an airport tenant's failure to pay rent. **Motion carried unanimously.**
