# City Commission Regular Meeting

## Tuesday, September 24, 2024

Video and Agenda Packet

Mayor Fred Cleveland called the meeting to order. Also in attendance were Commissioners Randy Hartman, Lisa Martin, and Jason McGuirk. Vice Mayor Valli Perrine was excused. Staff present were City Manager Kevin Cowper, Assistant City Manager Ron Neibert, City Clerk Kelly McQuillen, and City Attorney Carrie Avallone.

#### **CITY MANAGER'S REPORT**

- Glenn Storch, the Deering Park Innovation Center attorney, requested that the first reading for the DPIC PUD be continued until the 1/28/25 meeting. A work session will be held prior to 1/28/25.
- Staff members are meeting to follow up on developing a comprehensive community calendar.
- The City's offer to sell the property at 120 Flagler Ave. received no bids; options for what to do with that property will be forthcoming.
- City staff will be meeting with Venetian Bay developer's representatives, business owners, and residents to discuss ongoing concerns about parking in the area.
- City staff and the city's parking consultant met with county staff along with their off-beach parking contractor, to discuss collaboration between the city and county systems.
- City staff have been making plans to deal with the impact of Hurricane Helene.

#### **PUBLIC PARTICIPATION**

- Glenn Storch, representing the Deering Park Innovation Center applicant, reiterated the desire to receive as much input as possible from staff and stakeholders in the community before moving forward with the application.
- Three business owners on Flagler Ave requested better management of flooding conditions on Flagler, especially related to the impact of traffic-induced wakes that flow into businesses.
- A resident spoke about widespread flooding requesting a moratorium on any new development and a plan to move forward.
- One resident spoke on the need for public input on the Deering Park project, on the revised parking study report, and on several items in the Consent Agenda.
- A resident spoke on the need to coordinate City activities with the County and other agencies, and about problems with flooding related to construction along Pioneer Trail.
- One resident spoke about problems of flooding along A1A between 11th and 13<sup>th</sup> Avenues.

#### **ORDINANCES - SECOND READING AND PUBLIC HEARINGS**

- 9.A Ordinance No. 53-24: Conduct the Second Reading and Public Hearing of an Ordinance, which if
  adopted, would amend the City Code to require business impact estimates for certain municipal
  ordinances. Approved unanimously.
- 9.B Ordinance No. 54-24: Conduct the Second Reading and Public Hearing of an Ordinance, which if adopted, would approve the Proposed Annual Budget of the Utilities Commission, New Smyrna Beach, for the Fiscal Year of October 1, 2024, through September 30, 2025. Approved unanimously.
- 9.C Resolution No. 71-24: Consider the adoption of a Resolution, which if adopted, would approve the Fiscal Year 2024-2025 CRA Budget. **Approved unanimously.**
- 9.D Resolution No. 68-24: Consider the adoption of a Resolution, which if adopted, would adopt the final New Smyrna Operating Millage Rate at 4.6370. **Approved 3-1 (Martin voted no).**
- 9.E Resolution No. 69-24: Consider the adoption of a Resolution, which if adopted, would adopt the final New Smyrna I & S 2018 Maximum Millage Rate. **Approved unanimously.**
- 9.F Resolution No. 70-24: Consider the adoption of a Resolution, which if adopted, would adopt the final New Smyrna Beach Budget for Fiscal Year 2024-2025. Concerns were raised about giving double digit raises to several staff and whether those amounts should be spread out over 2-3 years. Approved 3-1 (Martin voted no).

#### **MAYOR AND COMMISSION REPORTS**

- Commissioner Martin voiced concerns about increasing millage rate on top of increased valuations;
   applauded the donation of the new sculpture at Watch and Warn Park.
- Commissioner McGuirk has concerns about members of the commission that don't approve the proposed millage rate because it reflects an increase needed to fund the budget.
- Commissioner Hartman felt that a nepotism policy report is needed.
- Mayor Cleveland applauded the Police Marine Unit for its approach enforcement and protection of the lagoon and waterways and commended staff for the preparation efforts for Hurricane Helene.
